Software Development Manager, Bristol

Role function:

Global poverty is falling fast, yet 1.2 billion people across the world still live in extreme poverty. Development Initiatives (*DI*) believes that we can end extreme poverty by 2030, but need better information to do so. Our role is to help people to access – and use – data and information about ending poverty.

DI has been instrumental in establishing and managing the International Aid Transparency Initiative (**IATI**). **IATI** is an open data standard, allowing detailed information on who is spending what, where, with what results to be shared in a common electronic format. This is an exciting time for IATI: with over 290 publishers it is reaching critical mass in providing detailed and timely open data on financial flows coming from a wide range of aid and development actors. These 290+ publishers are the tip of the iceberg. We need to support more organisations to publish open data, and drive up the quality of the data being published.

In addition **DI** is developing an ambitious information system that will join up data on resource flows and socio-economic indicators from a range of different global and national sources.

We are looking to recruit an experienced Software Development Manager to help us manage the *IATI* Standard, its code, and technical infrastructure as well as oversee the development of *DI*'s information system. You will be part of an expanding multi-disciplinary technical team engaging with all aspects of *DI* and *IATI* work.

Role content:

IATI

The *IATI* Standard has an agreed process of change control for which you will be responsible. This involves:

- Communicating with communities of interest about plans for change
- Carrying out consultation of proposed changes to the Standard with a wide range of stakeholders around the world
- Planning adoption cycles for new versions of the IATI Standard
- Maintaining audit trails and documenting changes
- Managing the process within the IATI Technical team
- Working with the Technical Lead to agree the specific technical details of changes

You will manage our team of two developers to:

Prioritise software development work

- Manage the IATI GitHub Organisation
- Improve deployment processes
- Future proof existing projects to changes in the IATI Standard
- Support existing software that we have created, adapted or manage
- Improve the quality of that software
- Engage in development cycles for existing and new products
- Communicate with users of our software
- Help others understand IATI data through the products you maintain and support
- Maintain public facing services so that there is minimal downtime

You will be working with a core UK-based team, but engaging with a wide network of practitioners around the world, including opportunities to travel. You will need to be prepared to take on a range of tasks, learning as you go, and working in a busy and varied environment. In any month you might find your team:

- Creating routines to generate reports on some or all of the published IATI data;
- Updating software to work with new versions of the IATI standard;
- Working with our Single Source of Truth to generate up to date documentation;
- Working with the wider team to explain the nuances and implications of changes to code.

DI

You will oversee the development of DI's new back-end database and front-end visualisation platform and data service.

- You will manage and coordinate the work of DI's in-house database and front-end developers.
- You will coordinate this work with DI's data analysts and communications and engagement teams
- You will improve the hosting environment of both DI and IATI systems by managing contracts with hosting providers to ensure they provide a well-managed service.

- Be responsible for ensuring that all websites and deployed software are working;
- Ensure software bugs and issues are reported and fixed;
- Build and maintain collaborative relationships with the developer community;

- Write content for websites, blog posts and newsletters;
- Increase and improve communications about new data and data quality and engage with the IATI publisher community through online fora etc.;
- Work collaboratively with a variety of institutions and individuals across the IATI network
- Identify and implement, wherever possible, efficiency and other improvements in day to day working practices
